As part of April's celebration of *Women & Girls' Wellness Month* in Virginia, WOMEN'S HEALTH VIRGINIA is presenting *REFLECTING WOMEN'S WELLNESS 2010*. This juried show will feature art by women or about women or girls, as a demonstration of the importance of art to women's well being, for the artist and the observer. By hosting this and other events, Women's Health Virginia raises awareness of the importance of women and girls' wellness and the variety of medical and non-medical issues that affect their health and well being.



#### ELIGIBILITY

The exhibition is open to male and female Virginia artists age 18 and over.

#### PRESENTATION

Two-dimensional works in all media will be considered. Each piece may be no larger than 32" x 40", including the frame. All work must be the original work of the entrant, suitably mounted or framed, using Plexiglas where appropriate, no glass, and with hardware ready for hanging.

#### ENTRY PROCEDURE

A non-refundable entry fee of \$25 must accompany the application (use form below or on WHV web site). Artists may submit 2 works. Entries can be submitted electronically or by photo or digital print no larger than 8½" x 11". If a photo or print is submitted, it should be labeled on the reverse side with the artist's name, title of the work, medium, framed size, and selling price (or NFS). Notification of the jurors' decisions will be e-mailed. If you do not have e-mail, include a self-addressed, stamped envelope for your notice. Entries must be received no later than 5 p.m. March 1, 2010.

#### LIABILITY

Neither Women's Health Virginia, Faison & Associates, Inc., James Center Property LLC, nor the Richmond Marriott West or Marriott Inc. will be liable for loss, theft or damage to any entry submission or work exhibited in the show. Due care will be taken in handling entries and artwork. Your entry into the exhibition

indicates your acceptance of these terms and conditions and assumption of risk regarding the submissions.
