Specifications

All work submitted must be original and completed within the past two years. All media eligible. No saw tooth hangers. 2D work should be matted (neutral color) when appropriate.

Deadline

All entries must be received by **January 16, 2009**. All work must remain on display for the duration of the exhibit.

Entry Guidelines

Artists must hand deliver actual works.

Fees

A non-refundable entry fee must accompany the submissions. Please note our fee schedule. \$25.00 for first work, \$5.00 for each additional work entered. (FCCA members: \$15.00 first work, \$5.00 for each additional.) Make checks payable to: Fredericksburg Center for Creative Arts (FCCA).

Agreement

FCCA reserves the right to reject from exhibition works accepted by juror, due to content or inability to properly install the work. A 25% donation of sale price is required of all sales. By submitting work for entry, artist agrees to allow representations of work to be shown and reproduced for publicity purposes.

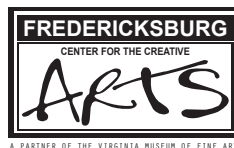

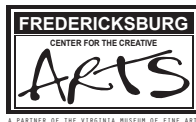
