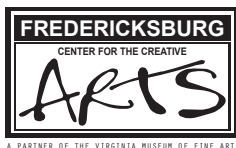

Entry Deadline: March 27, 2009

Eligibility

This exhibition is open to all artists. Please, no work previously juried and accepted in the FCCA Frederick Gallery.

Specifications

All work submitted must be original and completed within the past two years. All media eligible. All 2D work must be ready to hang. No saw tooth hangers.

Deadline

All entries must be received by **March 27, 2009**. Please allow for any holiday mail delays. All work must remain on display for the duration of the exhibit.

Fees

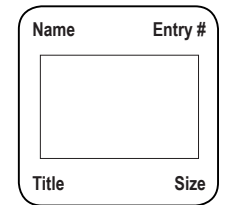
A non-refundable entry fee must accompany the submissions. Please note our fee schedule. \$25.00 for first work, \$5.00 for each additional work entered. (FCCA members: \$15.00 first work, \$5.00 for each additional.) Make checks payable to: Fredericksburg Center for Creative Arts (FCCA).

Entry Guidelines

Submit slides, JPG images on CD, or original artwork.

- CD images should be no larger than 1500 pixels in the longest dimension.

- Slides must be 35mm (2" x 2") cardboard or plastic mounts.



The FCCA retains the slides of accepted artwork. Provide a SASE for return of declined slides (min. of \$0.59 postage). Indicate Name, Entry #, Title, and Size as shown.

Agreement

FCCA reserves the right to reject from exhibition works accepted by juror, due to content or inability to properly install the work. A 25% donation of sale price is required of all sales. By submitting work for entry, artist agrees to allow representations of work to be shown and reproduced for publicity purposes.

Juror

Hubert Jackson was born in Culpeper, Virginia in 1943. He received a Bachelor's degree in fine arts education from Virginia State University in 1965. After moving to the Washington, DC area in 1965 he began a teaching career which spanned 34 years. He received a Master of Fine Arts degree from Howard University in 1971, and did further studies at the Corcoran School of Art. Jackson served on the selection committee for the District of Columbia Artists in Schools program sponsored by the DC Commission of The Arts and Humanities from 1977-1979. He served as a curriculum writer for the DC Public Schools. His paintings have been selected for inclusion in the Art in Embassies Program of the U.S. State Department. After retiring from the Washington, DC Public School System in 1999, where he taught art and photography at Woodrow Wilson High School, Jackson moved to Colonial Beach, Virginia, where he maintains his studio.
