## Specifications

All work submitted must be original and completed within the past two years. All media eligible. All 2D work must be ready to hang. No saw tooth hangers.

## Deadline

All entries must be received by **March 25, 2011**. Please allow for any holiday mail delays. All work must remain on display for the duration of the exhibit.

## Fees

A non-refundable entry fee must accompany the submissions. Please note our fee schedule. \$25.00 for first work, \$5.00 for each additional work entered. (FCCA members: \$15.00 first work, \$5.00 for each additional.) Make checks payable to: Fredericksburg Center for Creative Arts (FCCA).

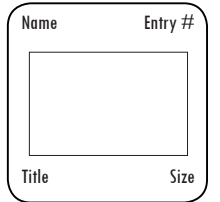
## Entry Guidelines

Submit slides, JPG images on CD, or original artwork.

- CD images should be no larger than 1500 pixels in the longest dimension.

- Slides must be 35mm (2" x 2") cardboard or plastic mounts.

The FCCA retains the slides of accepted artwork. Provide a SASE for return of declined slides (min. of \$0.62 postage). Indicate Name, Entry #, Title, and Size as shown.



## Agreement

FCCA reserves the right to reject from exhibition works accepted by juror, due to content or inability to properly install the work. A 25% donation of sale price is required of all sales. By submitting work for entry, artist agrees to allow representations of work to be shown and reproduced for publicity purposes.

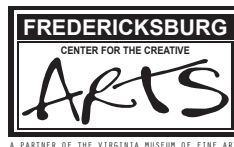

**Joseph Di Bella**, Distinguished Professor of Art, has taught at the University of Mary Washington in Fredericksburg, Virginia since 1977. He served as chair of the Department of Art and Art History from 1990 to 1993 and 1996 to 1999 and Director of University Galleries from 1983 to 1988. He was instrumental in the establishment of the Ridderhof Martin Gallery at Mary Washington. From 1994 to 2003 he was co-director of the University's program in Urbino, Italy. He holds a BA in art history from Rutgers and MA and MFA degrees in painting from Northern Illinois University. A signature member of the National Watercolor Society and affiliated with other professional art organizations, he has exhibited in regional, national and international venues.
