## Eligibility

This exhibition is open to all artists. Please, no work previously juried and accepted in the FCCA Frederick Gallery.

## Specifications

All work submitted must be original and completed within the past two years. All media eligible. All 2D work must be ready to hang. No saw tooth hangers.

## Deadline

All entries must be received by **May 27, 2011**. Please allow for any holiday mail delays. All work must remain on display for the duration of the exhibit.

## Fees

A non-refundable entry fee must accompany the submissions. Please note our fee schedule. \$25.00 for first work, \$5.00 for each additional work entered. (FCCA members: \$15.00 first work, \$5.00 for each additional.) Make checks payable to: Fredericksburg Center for Creative Arts (FCCA).


## Entry Guidelines

Submit slides, JPG images on CD, or original artwork.

- CD images should be no larger than 1600 pixels in the longest dimension.

- Slides must be 35mm (2" x 2") cardboard or plastic mounts.

The FCCA retains the slides of accepted artwork. Provide a SASE for return of declined slides (min. of \$0.62 postage). Indicate Name, Entry #, Title, and Size as shown.

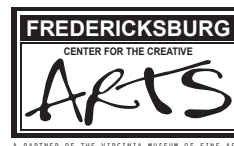

**Anne Timpano** earned a B.A. in Art History at the College of William and Mary, Williamsburg, VA, and an M.A. in Art History at George Washington University, Washington, D.C. She has served as Director of University of Mary Washington Galleries since 2008. Previously, she was Director, DAAP Galleries, University of Cincinnati, 1993-2007. While at UC she also founded the Museum Studies Certificate Program for which she also served as Director. Prior to that, she served as Director of the Columbus Museum in GA for seven years and began her museum career at the Smithsonian American Art Museum. Timpano has served as a juror for art exhibitions, lectured on topics relating to the history of American art, and organized museum and gallery exhibitions. She has served as a surveyor for the Museum Assessment Program of the American Association of Museums (AAM), and has reviewed grants for the Institute of Museum and Library Services and the Georgia Council for the Arts. Timpano is a member of the AAM and is active in its Committee on Museum Professional Training.
