The EXHIBITOR, _____, agrees to deliver **all artworks** accepted to be exhibited, including an **artist statement** and an accurate **inventory list**, including valuation, to FCCA at 813 Sophia Street, Fredericksburg, VA 22401 on/or by the date of July 24, 2009 (gallery hours Mon-Sun 12-4, closed Tues & Wed). Exhibitor agrees to deliver artworks in suitable condition for public display, and with all artwork labeled on back with artist name, title of artwork and exhibit title. Exhibitor agrees to arrange return shipping as specified on FCCA congratulatory document. Exhibitor agrees to remove artwork by August 29, 2009. Any artwork remaining ten (10) days after this date becomes the property of FCCA. The exhibitor agrees to pay FCCA its 25% commission on all artwork exhibited at FCCA that is sold within 60 days of the close of the exhibition if the sale is a result of exposure gained from FCCA. FCCA reserves the right to reproduce accepted artwork for publicity purposes, including posting on our website, during the run of the exhibition, and for one year thereafter. **All artworks will remain on display for the duration of the exhibition (no exceptions).**
