

## Call for Artists: 2010 Members' Gallery Exhibits

### Requirements Checklist:

- Application form (at FCCA or can be downloaded from the website, fccava.org)
- 1 original work created within the last two years (must be left until the jury panel meets.)
- 4 additional images in jpeg format on CD or slides. Write "Members' Gallery Application" and name of artist directly on the CD. Digital images must be saved at a resolution of 300 dpi with no more than 1500 pixels in its longest dimension. Each image must be titled with the name of the artwork and number given to that work on the application form. (For example: SelfPortrait1.jpg.) Slides must be individually labeled on the front with the title of the artwork and name of the artist.
- Check for \$35 made payable to FCCA to help defray the cost of the evaluation team.
- SASE (*Self-addressed, stamped envelope for evaluation and letter*-- note: CD will not be returned. Include enough postage to cover the return of slides.)
- **Due August 1-3, 2009 during regular open hours.**
- Artwork and application packet will be placed in the Members' Gallery until jurying and must be labeled clearly with the artist's name and Members' Gallery Submission, 2010
- FCCA membership must remain current.

The selection process for Members' Gallery Exhibits has been refined over the last several years to be as fair, anonymous and confidential as possible. A panel of jurors is chosen to meet and evaluate the readiness of artists to have a solo or two person show. *They are looking for artists with a unified body of work well-presented by high quality images.* This team of jurors will include members both from academic backgrounds and be working art professionals. At the end of the process, each artist will receive an evaluation form on which the panelists independently score the work and make written comments based on strength of composition and mastery of the medium. This is a selection process with a bonus and a unique opportunity for artistic growth.

As gallery space permits, those artists whose scores reflect a readiness to show will be offered a particular month in 2010. Artists should receive their invitations to exhibit and/or evaluations by September 1.
